### 2. COMPOSITION/ INFORMATION ABOUT THE COMONENTS

---

Complex combination of waxes, plasticizers, solvents, pigments and perfumes.

### 3. IDENTIFICATION OF DANGERS

---

Physical-Chemical Dangers: Product not classified as inflammable.

Health Risks for Humans: Product not classified as dangerous for health.

### 5. FIRE EXTINGUISHING MEASURES

---

Adequate means of extinction (of solids): Flow of powdered water, foam, CO<sub>2</sub>, extinguishing powder.

Specific Risks: In case of a fire, use powdered water to cool surfaces which are exposed to the fire, and to protect the personnel. Use foam, dry chemical powder or carbonic snow to extinguish the fire.

Warning: An incorrect application of the water may cause the water to bubble over and spread.

### 6. MEASURES IN CASE OF ACCIDENTAL SPILLAGE

---

If the Solid Material is spilled, sweep the zone and collect with a stick or something similar, and keep the product for its controlled elimination or for recycling.

If the Non-solid material is spilled, keep the personnel at a distance, let it solidify and recover the product for its elimination or for recycling.

### 7. HANDLING AND STORAGE

---

Handling: No special measures are required for the handling and storage of the solid material.

Storage: Keep the product away from sources of heat and preferably in a dry or cool place.

Hygienic measures: Do not eat, drink or smoke during use. Wash your hands completely after handling.
